<u>What is the overall deductible?</u>	<u>Network</u> : \$5,000 Individual / \$10,000 Family <u>out-of-Network</u> : \$10,000 Individual / \$20,000 Family Per calendar year.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. <u>Are there services covered before you meet your deductible?</u>	Yes. <u>Preventive care</u> and categories with a <u>copay</u> are covered before you meet your <u>deductible</u> .
