What is the overall Deductible ?	In-Network \$3,000 person/\$6,000 family; Out-of-Network \$18,900 person/\$37,800 family	Generally, you must pay all of the costs from Providers up to the Deductible amount before this Plan begins to pay. If you have other family members on the Plan , each family member must meet their own individual Deductible until the total amount of Deductible expenses paid by all family members meets the overall family Deductible .
Are there services covered before you meet your Deductible ?	Yes. Generic pharmacy, child vision, immunizations or In-Network hospice, services w/physician Copay and Preventive Care are covered before you meet your Deductible .	This Plan covers some items and services even if you haven't yet met the Deductible amount. But a Copayment or Coinsurance may apply.
