What is the overall <u>deductible</u> ? Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , Tiers 1, 2, and 3 <u>prescription drugs</u> , <u>provider</u> office visits, Non-hospital affiliated facility day surgery, Non-hospital based laboratory and imaging, and <u>Rehabilitation services</u> , and <u>Habilitation services</u> are covered before you meet your <u>deductible</u> .
