What is the overall <u>deductible</u> ? Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , certain preventive prescription drugs, and Preferred Network <u>provider</u> routine eye exams are covered before you meet your <u>deductible</u> .
