What is the overall <a href="#">Deductible</a> ?	<a href="#">In-Network</a> \$2,500 person/\$5,000 family; <a href="#">Out-of-Network</a> \$18,900 person/\$37,800 family	Generally, you must pay all of the costs from <a href="#">Providers</a> up to the <a href="#">Deductible</a> amount before this <a href="#">Plan</a> begins to pay. If you have other family members on the <a href="#">Plan</a> , each family member must meet their own individual <a href="#">Deductible</a> until the total amount of <a href="#">Deductible</a> expenses paid by all family members meets the overall family <a href="#">Deductible</a> .
Are there services covered before you meet your <a href="#">Deductible</a> ?	Yes. Generic pharmacy, child vision, immunizations or <a href="#">In-Network</a> hospice, services w/physician <a href="#">Copay</a> and <a href="#">Preventive Care</a> are covered before you meet your <a href="#">Deductible</a> .
