<p>What is the overall deductible?</p>	<p>\$2,900/Individual, \$5,800/Family in-network providers; \$5,000/Individual, \$10,000/Family out-of-network providers. Deductible applies to all services, including prescription drug, before any copayment or coinsurance are applied.</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, the overall family deductible must be met before the plan begins to pay.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. in-network preventive services.</p>	<p>This plan covers some items and services even if you haven't yet met the annual deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible. Combined out-of-pocket limit for network medical and prescription drug.</p>	<p>The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.</p>
<p>What is not included in the out-of-pocket limit?</p>	<p>Premiums, balance billing charges, and health care this plan doesn't cover.</p>	<p>Even though you pay these expenses they don't count toward the out-of-pocket limit.</p>
